Letter to the Editor

Lies, Damned lies, and Statistics

I have worked extensively with the FORR Safety Program in the past and would like to make a comment here about "statistics". The greatest single piece of advice I have ever gotten regarding this subject came from Terry Lee Cook's late father Joe. He told me "Smokey, figures don't lie, but there are a LOT of liars that figure!".

Most of the bureaucrats writing these statistics don't know a damned thing about motorcycles, many hate them(and us) and will do anything to get us off the streets, and some are actually jealous that we still have the courage to live our lives in freedom as the Founding Fathers of this country intended. They use their power and position to try to punish us in any way they can. I have spent much time in the Capitol in meeting rooms with such people and sometimes they make my blood boil (Ask Carl Hammond about the time I blew my cool in a meeting regarding state funding for rider education. You will have to wait several minutes to give Carl time to stop laughing).

Right now one of the biggest things these "experts" are trying to do is discredit motorcycle rider education and claim it is ineffective. The latest is an "expert" from the CDC who, as you know, are also big time in the business of pushing helmet laws now (you can see this guy's picture in an encyclopedia under the heading "Complete and Total Dickhead!"). This "expert" has never taken a class, admits he's never even seen a class, but thinks he knows everything about them.

In that file were DOZENS of letters from former FORR Rider Education students who thanked the Program, their course instructors, and the assisting BEST members for teaching them a technique(or sometimes several techniques) that had saved their lives on the streets. I completely lost count of the number of phone calls I had telling me the same thing. I can't tell you how many times the things I learned by being an instructor saved my own bacon. Want to go a little farther up the "bureaucrat's" food chain for an opinion? Find former Cole County Sheriff Heymeyer. I personally trained nine of his deputies in a beginner's class at our Jefferson City site in 1989. The next day after that class was completed, Sheriff Heymeyer called me and had nothing but complete praise for the FORR Rider Education Program and the excellent skills we had taught his deputies.

I would like for some of the bureaucratic "experts" to name me one other single profession, job, or activity of any kind that is not improved and made safer by skilled and correct education and we DO TEACH skilled and correct techniques in our Rider Education classes! If education is not effective, why do our high schools offer driver's education? Why do judges send drivers who have been convicted of traffic offenses to driver education classes?

As for the "experts" lumping ATVs in with motorcycles in "statistics" and saying that motorcycle riders were not wearing "protection" because they weren't using seat belts (what the hell is that all about?!!), bureaucrats have been trying to mix oil and water together using totally stupid and meaningless comparisons for 50 years! And we are PAYING them to do this useless, misleading, and totally counterproductive bullshit!

To any such bureaucrat reading this, if you ever meet me in real life and try to tell me some such crapola, on a good day you will get the biggest ass-eating of your entire miserable, boxed-in, henpecked, triple-condomed, and air-bagged life. McDonnell, Crash and Carol Harrison, Terry Lee Cook, Ron Brant, and all the other instructors and BEST members that have made our nationally award winning Program what it is today. And extend a high and proud middle finger every time you pass the taxpayer built office building housing our "wonderful" safety expert bureaucrats. Then shout at the top of your lungs "Get a life, motherf@#kers!" Sorry for the long letter, folks, but this subject really fires me up sometimes! be free, Smokey

One of the things I love about Fall is how the cold air makes our engines run stronger and harder, especially V-twins. It seems like my old Drifter has picked up 5 horsepower since the weather got cooler. Now if anybody has a remedy for the highway patrol and radar.....

IMPORTANT NOTICE: OUR DECEMBER MEETING WILL BE HELD AT THE CHRISTMAS BANQUET SATURDAY NIGHT, DEC. 6TH, NOT ON SUNDAY, DEC. 7TH. Tami suggested this at our November meeting and I'm glad she did. I have a 190 mile round trip to Glasgow and I'd hate to have to make another trip to Poodle's II Palms the next day. Remember, everybody needs to bring a wrapped gift that costs \$10 or less to the Christmas Party. And I'm still looking for a Love Ewe inflatable love sheep that costs ten bucks or less. Can anybody out there help me? Here's a big tip of the local 12 FORR cap to Nancy Engelhardt with the MO Dept.. of Transportation for her help in getting the west sign on our stretch of 240 Hwy. that we are keeping clean fixed after it was bent and damaged. I called Nancy after Socko told me the sign was damaged and in less than a week it was up, good as new. Not all state employees are slower than molasses in January.

Local 12 voted at our October meeting to donate \$500 to breast cancer research and proved once again that bikers have the biggest hearts in the world. I never met a biker that didn't love kids and they always love us right back. Remember, if they love us when they're kids, they're more apt to be looking for us as adults. And many of them will become riders, when they're old enough. Always plan for the future, folks.

We have another great Christmas Party coming up, this one in Sedalia with all our friends in locals 13 and 14. The date is 12/13/14, the same numbers as the locals participating. This was originally an idea from my dear Brother and much-missed friend, Crash Harrison. The idea is to get everyone in all our locals better acquainted and hopefully increasing attendance at all 3 local's events. It's a fabulous idea, typical of most all of the ideas Crash came up with when he was here with us. Here's a huge tip of the local 12 FORR cap to you, Brother Crash. I'm sure you're grinning and laughing that wonderful raspy laugh that only you had. Damn, I miss it. Location of the party is the Best Western Inn on Hwy. 65 south, right across the street from Yeager's Harley Davidson. Their phone number is 660-826-6100. The party will start early in the evening, around sixish or so. Get your reservations early folks, this could be a big one!

I'd like to send a huge "thank you" and tip of the local 12 FORR cap out to Mike and Tami Adcock, Butch Johnson, Barry and Susan McDaniel,

Laura and Socko Adcock, David Kateman, and John Stouffer and Joyce Hibbard for their help on our last highway trash pickup on Nov. 2nd. We filled a bunch of bags and that stretch of 240 Hwy. looked 100% better when we finished. Afterwards we held our November meeting at Poodle's II Palms in Boonesboro. Both my minutes and Laura's treasury report were approved as read. John reminded us to vote and do so for motorcycle friendly candidates.

Socko thanked everyone for the great job they did on the trash pickup and for their attendance at the meeting. In old business, at next year's Firecracker Classic we will be opening the gates at 4 pm instead of noon. This will give us more preparation time and we don't get much of a crowd until then, anyway. As mentioned earlier, our December regular meeting will be held at Beckett's during the Christmas party. This is a nomination meeting for the 2015 officers so it is important for as many members as possible to be there.

I'm going to end with 2 maintenance tips for this winter when it's too cold and slick to ride and we're getting our bikes ready for next year. When I worked as service manager at Doug's Cycle Shop, the no. 1 neglected maintenance problem was tire pressure. No. 2 was brake and clutch fluid (if the bike had a hydraulic clutch). Brake fluid should be changed at least every two years. Clutch fluid should be changed yearly. Why twice as often for clutch fluid? Clutch fluid works harder. Every time you take off, your clutch fluid gets pulled through a full stroke four or five times. Brakes are only used when you stop and only go through a partial stroke. I've observed it on my own bikes time and time again and the clutch fluid gets dirtier much faster. If either brake or clutch fluid darkens at all, get it out of there and put in new.

When I worked at Doug's we had a front brake master cylinder on the front counter that was full of what looked like sand. It wasn't sand, it was crystallized brake fluid that had been left in there for many years. It came off a KZ650 Kawasaki. The rider of that bike had cooked into a corner a little too hot, put on the front brake, the master cylinder reused to release, the front brake locked, and the bike went down hard. The rider got road rash a bunch because he was riding in a t-shirt and shorts (dumb, dumb, dumb!). Take care of your brakes, folks, and they will take care of you.

If you do your own maintenance, get a Mity-Vac vacuum pump at your auto parts store or on-line motorcycle parts retailer and turn a tedious job into one that only takes a matter of minutes. I change both brake and clutch fluids yearly and that little pump is worth it's weight in gold.

Tip no. 2: have a fuel injected bike that is not starting like it used to, smoking on cold startup, down on fuel mileage, and throttle response not as crisp as it used to be? Before you spend big bucks at a shop, try this: go to your local auto parts store and get an aerosol can of Seafoam fuel injection cleaner. Remember, aerosol, not the liquid in a can. Take a ride to warm the bike up thoroughly, park it, remove the air filter cover and air cleaner, then turn the idle up about 1,000 rpm (go by ear if you don't have a tach, this will be a very fast idle) then stick the can nozzle in very close (1/4 inch) to the brass throttle butterflies, then spray the cleaner until the motor lugs way down, accompanied by huge clouds of white smoke, then quit spraying until it goes back up to the high idle

speed. Do this until the entire can is gone, let it run a couple of minutes longer, then replace the air filter and filter cover. Immediately start it back up, turn the idle down to normal speed, then go for a ride with lots of hard throttle roll-ons and aggressive riding. Go at least 10 miles to thoroughly distribute the Seafoam throughout the throttle body. You may hear some backfiring as the gunk and carbon it has loosened breaks loose and goes out the pipes.

One caution: both the cleaner and cleaner fumes are VERY toxic. This job must be done outdoors, in a place with very good ventilation. Don't get any of it on your paint if you want an unblemished bike. When I did this to my Drifter, it ran better than it has run during the whole 32,000 miles on the odometer. I don't guarantee it will cure all fuel injection problems, but it does a hell of a job on gunk and carbon. This tip courtesy of Doug's Cycle Shop in Salisbury, MO.



In 1956 the Highway Revenue Act established the Highway Trust Fund which directed federal fuel taxes into the Trust Fund to be used exclusively for highway construction and maintenance. The Act of 1956 mandated a tax of 3 cents per gallon. In 1983 the Surface Transportation Assistance Act increased the tax to 9 cents per gallon with 1 cent going into a new Mass Transit Account. President Bush with the signing of the Omnibus Budget Reconciliation Act of 1990 increased the tax to 14 cents. In 1993 the tax was increased to 18.4 cents per gallon.

From 2008 through 2010 this fund was basically insolvent with Congress either authorizing payment from the general fund or authorizing emergency stop gap funding.

How does this apply to motorcycling you ask. Well the funding and reauthorization of the Highway Trust Fund has become a vehicle for the federal government to establish omnibus transportation bills which include a lot of issues that apply to various forms of surface transportation. These bills have been called by a number of names over the years. Things such as the Intermodal Surface Transportation Efficiency Act (ISTEA for short); the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A legacy for users (SAFETEA-LU) and the most recent Moving Ahead for Progress in the 21st Century Act (MAP-21). Are we confused yet? I challenge each of you to say any of these names 3 times fast.

I bring these issues up because right now the deadline for reauthorization has been extended by Congress. This means that over the course of the next year or so you will be hearing a lot about MAP-21 as Congress cusses and discusses the various issues of this huge transportation bill. One of the key issues that always comes up during

reauthorization discussion and one of the goals of MAP-21 is the highway safety improvement program (HSIP). This is one of DOT's number one priorities. I hope all of you are smart enough to see where this is going and why we need to be involved with our elected officials in DC.


The MRF is currently actively watching the federal transportation legislation to make sure motorcyclists interested are protected. That our safety grant money remains intact and that our freedoms are preserved. However they can only do so much. The rest is up to you. Do you know who your federal elected officials are? Have you been in contact with them? I hope the answer to both of those questions is a resounding "YES". If no maybe its time you picked up the phone or a pen and paper and made contact.

OK enough of the history err political lesson. I know some of you didn't join FORR to be politically active and just joined to attend the parties and have someone to ride with. Well unfortunately riding season is taking a short hiatus but will be back again soon. So take this down time to make sure your scoot is up to snuff. Do some much needed maintenance on the ole gal while the weather is cold so she'll be ready to go come the warm days of spring.




